Services & Fees Schedule 2012-2013

Welcome to EastLake Church-Home Base. Our before and after school child care program is a Christian program and it is operated by EastLake Church, a nonprofit corporation. The school age child care program is licensed by the California State Department of Social Services, Community Care Licensing Division.

Annual Registration Fee: Non-refundable. \$100.00 per student or \$150.00 per family

Non-refundable deposit of one week's tuition due at time of registration.

(Deposit will be applied to tuition the final week of the school year)

Annual Tuition

Annual Tuition paid in the following installments: Payment of first week's installment due one week before start date.

Auto Debit (electronic transfer) of weekly installments on each Friday for the following school week thereafter.

** All fees include transportation - services are available to students attending local schools that are on our current van routes.

Additional Childcare Fees:

Late Pick Up Fee – After 6:00 p.m. **\$15.00** (for each 10 min. interval)

Returned Payment Fee- Account balance becomes delinquent. **\$25.00**

Late Payment Fee – Assessed Monday to any delinquent account. **\$15.00**

Delinquent balance is due and payable by cash, cashiers check, credit card or debit card. An account over 30 days delinquent may cause dismissal of the student from our program as well as the account being sent to collections. **Interest and past due balance will be charged at the current legal rate.**

Additional Time (Daily Rate) Option – 24 hour notice required Dependent on space availability

There are no reductions for holidays, illness, family vacation or suspensions. A 2 week written notice is required for withdrawal and for a reduction in your child's schedule at any point during the school year. Tuition will continue to be due at the current tuition rate through the 2 week notification period. **No Intersession weeks will be included as part of the notification period.**

HOME BASE will provide services only when the local public schools are in session or when Intersession Camp Programs are offered.

Fees for Camp will be dependent on activities and hours of each individual camp program. **Students currently enrolled in Home Base will have opportunity to priority register for camp.**

A 30 day notice will be given to parents and posted at the school anytime there is a change in fees.
